U7 & U9

Allison spoke about the issues that U7 & U9 have been having for the past few seasons. Calling for improvements to the programs. Conversation continued about how to improve the program. Allison's recommendations are below.

U7

- No more than 14 kids per team.
- No more than 2 team at a time practicing
- · Head coach in place at the start for each team based on registration potential cap to registration
 - 2 practices a week throughout the seasons set schedule
 - No earlier than <u>9 am</u> practice time for weekends
 - Players must be able to skate independently
 - Offer a u5 or learn hockey program outside of u7.

U9

- Minimum 2 team practices a week
- · Head coaches in place for teams at the start of the year based on registration. Potential cap on registration if personal not in place
 - Smaller teams to facilitate more game play
 - Set schedule for the year
 - Transparency on the program from the start of the year
 - 2 teams on the ice at max

I would also like to see a spot-on registration to find out who is interested in head coaching, assistant coaching, on-ice coaching and managing.

Next Season Program

Motion (Trish Wilsner & Jessica Nemeth) to increase early bird and regular fees by \$25 and to add an additional \$100 late fee. Early bird pricing is in effect from June 1st to June 30th at midnight. Regular pricing is in effect from July 1st to July 31st at midnight. Late fee in effect from august 1st onward. This does not include new registrations.
